

960 ADVANCED UNDERWRITING

This unit aim to develop an understanding of the requirements of managing overall risk exposures and arriving at appropriate pricing to ensure fair outcomes.

It would be of benefit to those that are highly experienced in underwriting and that are in or aspire to senior underwriting and management positions.

It is assumed that the candidate has the knowledge gained from a study of the relevant sections of W01 Award in General or IF1 Insurance, legal and regulatory and M80 Underwriting practice or equivalent examinations.

- ❑ Analyze key regulation and legislation affecting the underwriting function.
- ❑ Evaluate underwriting strategy, policy and practice.
- ❑ Analyze the principles and practices of pricing.

BLENDED LEARNING INCLUSIONS

- ✓ Approximately 30 hours of pre-recorded video lectures broken down by learning objectives as per syllabus.

- ✓ The LVC will be scheduled every two weeks allowing the participants to go through the video lectures and text in their own time. Participants are expected to have prepared for the class to answer case studies and quizzes.
